---

Provide initial direction to demographer on composition of draft maps

# Criteria



## In order of priority:

- Equal Population
- Federal Law
- Contiguous
- Neighborhoods & communities of interest
- Understandable boundaries
- Compactness

# Neighborhoods & Communities

## Community of Interest:

Population with common social or economic interests that should be in a single district for fair/effective representation

## Examples:

Common assets like schools and shopping areas, housing, culture and language, and employment

Can consider existing data such as city planning information

No definitive dataset. **Need public testimony!**

# Things to Remember

---

**Strive for population equality.** Be prepared to justify deviations

**Focus on traditional criteria.** Draw contiguous districts that respect communities, while using understandable boundaries, and are compact when possible

**Do not use race as the predominant factor.** Only as one of many factors and cannot subordinate other redistricting criteria
